1. Existing Chimney is 50'-0"(+/-).

RFIs

- 1. What size and how much piping will be required when reinsulating (with PVC color coded jacket) the existing piping in the mechanical room? Drawings do not reflect the existing lines, nor sizes.
 - a. Should we carry an allowance for this work?
- **Answer:** The existing Chilled Water and domestic hot, cold and recirculating hot water piping insulation shall remain. Provide new insulation for the hot water supply and return pipes. All pipe insulation, new and existing, shall be covered with color coded PVC insulation. Cost of the insulation shall be included in the bid, no allowance.
 - 2. Will the long weekend coming up will the bid be extended?

Answer: Bid will not be extended

3. Can regular 20amp, 120V commercial grade toggle switches and red emergency plates be used for the two EPO switches?

Answer: Yes, this is acceptable.

4. What is the voltage, amps and phase of the two existing HWH-1 and HWH-2 domestic Hot water Heaters?

Answer: Bothe are 120V, single phase.

5. What is the Manufacturer and Model of existing panel HPB circuit breakers?
