## Manager - Water

### General Description:

This is highly responsible water treatment facilities supervisory work involving the supervision of a multiple municipal water treatment plants, water pumping station, watershed property and municipal water distribution system.

### Supervision Received:

Reports to the Director of Public Utilities.

### Examples of Duties:

Plans and directs work objectives and activities of a medium size work unit. Maintains operations on a continuous basis, remains on call 24-hours a day.

Interprets daily readings and laboratory analyses. Decides process changes, addition or deletion of equipment and determines process control parameters.

Counsels employees and supervises training, administers union contract language, oral and written warnings and suspensions, recommends higher level discipline, interviews job candidates and recommends selection, conducts employee performance evaluations and assures safe work practices.

Drafts bid specifications for the purchase of equipment, supplies and services.

Coordinates activities with other departments, including emergency services required by the weather. Maintains liaison with various local, state and federal agencies involved in monitoring and controlling Water Treatment activities.

Oversees operation of lab testing and reporting including the water quality monitoring report.

Recommends policy regarding water treatment. Initiates ideas/concepts for new or additional technological improvements. Prepares annual report and interim or special reports as required. Prepares state and federal reports.

Prepares annual budget and controls the expenditures of fund allocations within budgeted amounts.

Responds to citizen complaints or concerns regarding water treatment plant and distribution operations, issues or policies; investigates and resolves complaints.

Performs related work as required.

**Knowledge, Skills and Abilities:**

Considerable knowledge of engineering principles and practices that relate to the operation of a municipal water treatment and distribution system.

Thorough knowledge of the principles, technology and practices of operating and maintain a Class IV Water Treatment Plant, its pumping stations, and also operating and maintaining a Class III Water Distribution system.

Thorough knowledge of local, state and federal requirements regarding the operation of a water treatment plant and distribution system.

Considerable knowledge of public administration principles and practices as applied to water treatment plant and distribution system.

Thorough ability to direct and supervise a medium size work group over multiple divisions engaged in water treatment and distribution system operations and plant maintenance.

Considerable ability in oral and written communication.

Considerable ability to establish and maintain effective working relationships with superiors, associates, subordinates, officials of other agencies and the general public.

**Qualifications:**
